COOKING INSTRUCTIONS: FOR BEST RESULTS, DEEP FRY PARTIALLY DEFROSTED CAKES IN PREHEATED OIL (MEDIUM TO MEDIUM HIGH 350°-375°). PLACE CAKES INTO HOT OIL, FRY 4.5 MINUTES OR UNTIL GOLDEN BROWN OR INTERNAL TEMPERATURE OF 145° OR GREATER IS REACHED.
BAKING: PREHEAT OVEN TO 350°. PLACE CAKES ON SPRAYED OR OILED PAN, LIGHTLY BRUSH WITH OIL. BAKE CAKES 12-14 MINUTES OR UNTIL GOLDEN BROWN OR INTERNAL TEMPERATURE OF 145° OR GREATER IS REACHED.
